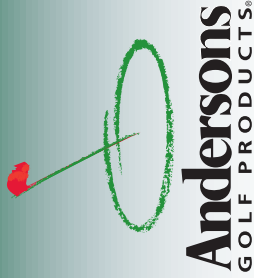

**DIRECTIONS FOR USE**

Apply only as directed during the growing season.

Use Andersons Golf Products ContecDG<sup>®</sup> Dispersing Granule Technology 24-0-10 for fairways and other turf areas where a high nitrogen and potassium fertilization is desired.

Watering in this product will disperse each granule into thousands of particles. This will facilitate the movement of the nutrients into the soil. This particle dispersion will also eliminate ball, shoe and mower pickup - minimizing nutrient loss.

**Application Rates:**

LIGHT: 4.16 lbs./1,000 sq. ft.  
LOW: 6.25 lbs./1,000 sq. ft.  
MEDIUM: 7.29 lbs./1,000 sq. ft.  
HIGH: 8.33 lbs./1,000 sq. ft.

**Spreading with PTO driven spreaders:**  
Excessive agitation of Contec DG can result in damage to the Contec DG particles. Keep the PTO operating at 540 rpm or less. DO NOT use agitation bars or stir bars, as this can result in the premature breakdown of Contec DG granules.

**Spreader Settings:**

Spreader settings are recommendations only and should be considered as a beginning point for user calibration. Results obtained by an applicator in the field may be different due to spreader production variations, spreader calibration differences, operating variables, and environmental factors (temperature, humidity, etc.). It is recommended that applicators check the pattern and delivery rate for their particular spreader periodically under their operating conditions using the actual product to be applied.

**For all applications:**

Immediately after application, apply a minimum of 0.2 inches of water to disperse the granules.

**Storage and Use:**

Store in a clean, dry place.  
Reseal opened bag by folding top down and securing.  
Use only clean, dry spreaders.  
Do not leave unused product in spreaders.
