DIRECTIONS FOR USE

Apply only as directed during the growing season.

Use Andersons Golf Products ContecDG® Dispersing Granule Technology 9-0-18 for greens, tees and other fine turf areas where a nitrogen and potassium fertilization is desired or when iron and manganese are needed to help correct or prevent deficiencies during the growing season.

Watering in this product will disperse each granule into thousands of particles. This will facilitate the movement of the nutrients into the soil. This particle dispersion will also greatly reduce ball, shoe and mower pickup - minimizing nutrient loss.

Application to wet, close-cut golf turf may result in foliar staining, which will discolor the turf to a brown/black appearance. This will occur even if immediate irrigation or rainfall occurs. Be sure to apply this product to dry turf only.

Application Rates:

- LIGHT: 1.8 lbs/1,000 sq. ft.
- LOW: 2.7 lbs/1,000 sq. ft.
- MEDIUM: 3.6 lbs/1,000 sq. ft.

Immediately after application, for optimum results, apply a minimum of 0.12 inches of water to disperse the granules.

- 40 lbs. feeds 22,200 sq. ft. (0.51 acre) with 0.16 lb. N/1,000 sq. ft. at the LIGHT RATE (1.8 lbs/1,000 sq. ft.)
- 40 lbs. feeds 14,800 sq. ft. (0.34 acre) with 0.24 lb. N/1,000 sq. ft. at the LOW RATE (2.7 lbs/1,000 sq. ft.)
